Determination of Offer Price and Allocation of Public Offer Shares

The Offer Price is expected to be fixed on or around Wednesday, 19 June 2019. Applicants are required to pay the maximum Offer Price of HK\$0.70 for each Public Offer Share together with 1.0% brokerage, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee. If the Offer Price is not agreed between the Company and the Sole Global Coordinator (for itself and on behalf of the Underwriters) at or before 5:00 p.m. on Thursday, 20 June 2019, the Share Offer will not proceed and will lapse.

Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.
